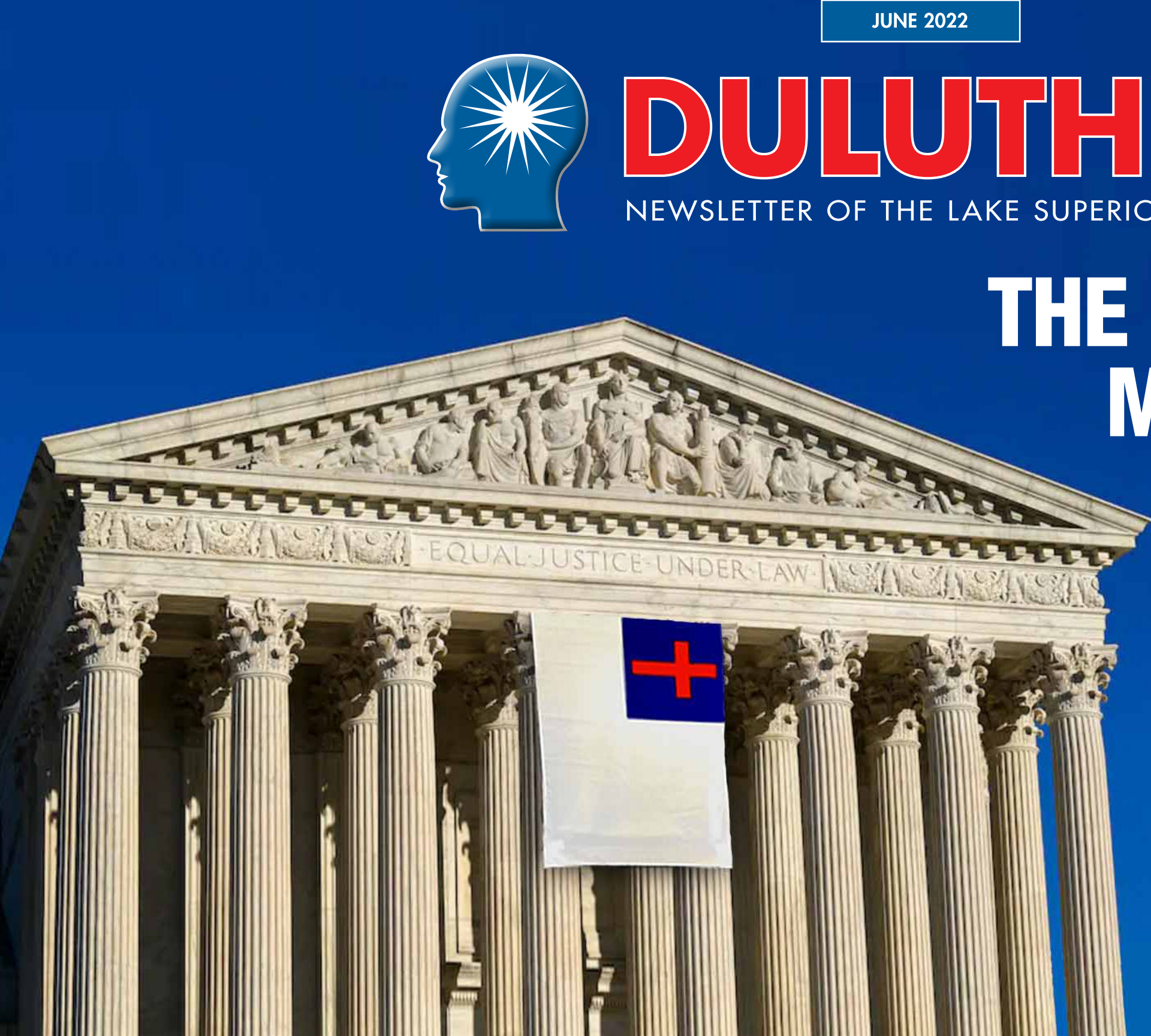

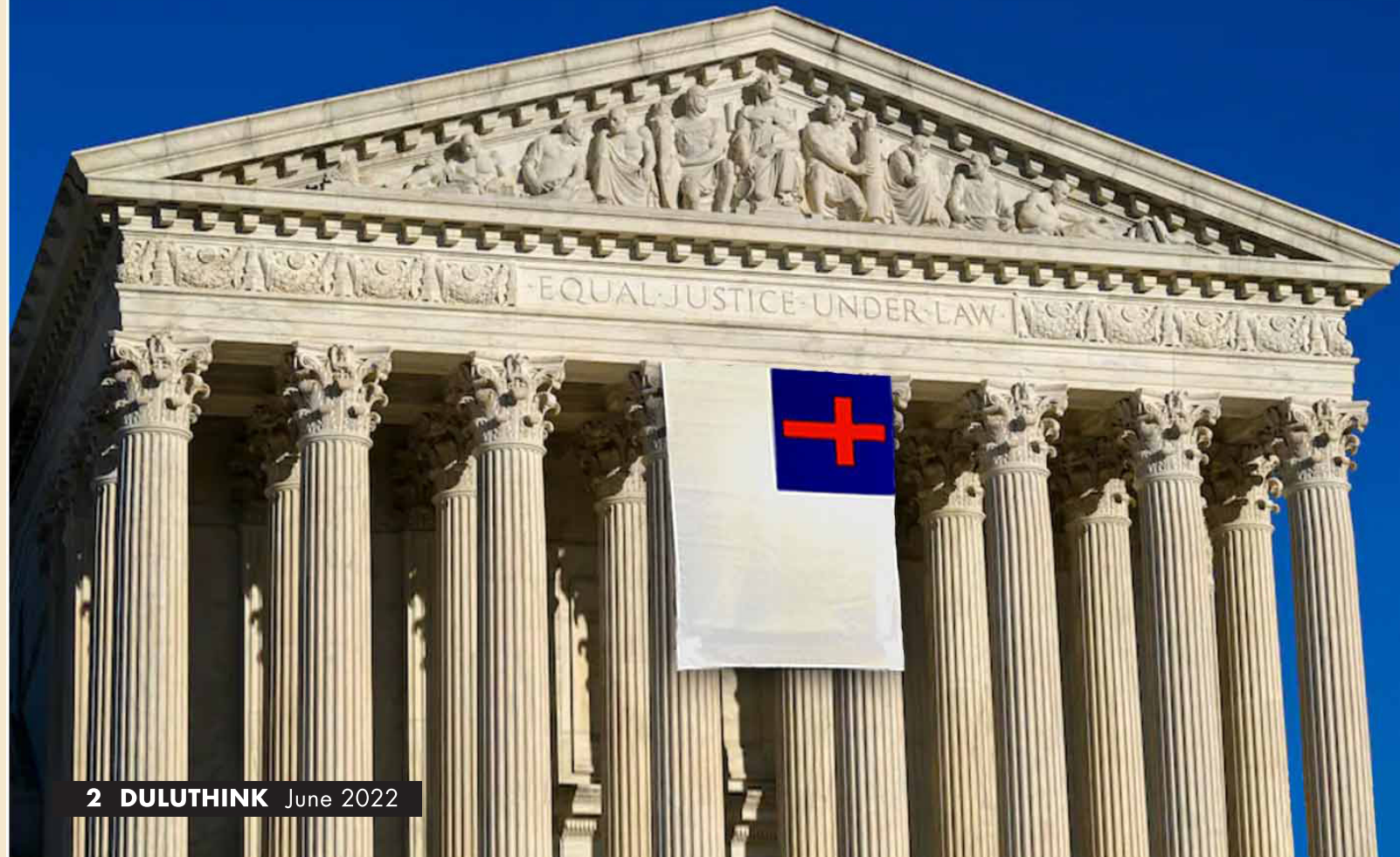

speech violations. Patrick is admitted to practice in Wisconsin, Minnesota, the U.S. Supreme Court, and many federal district and circuit courts around the country.

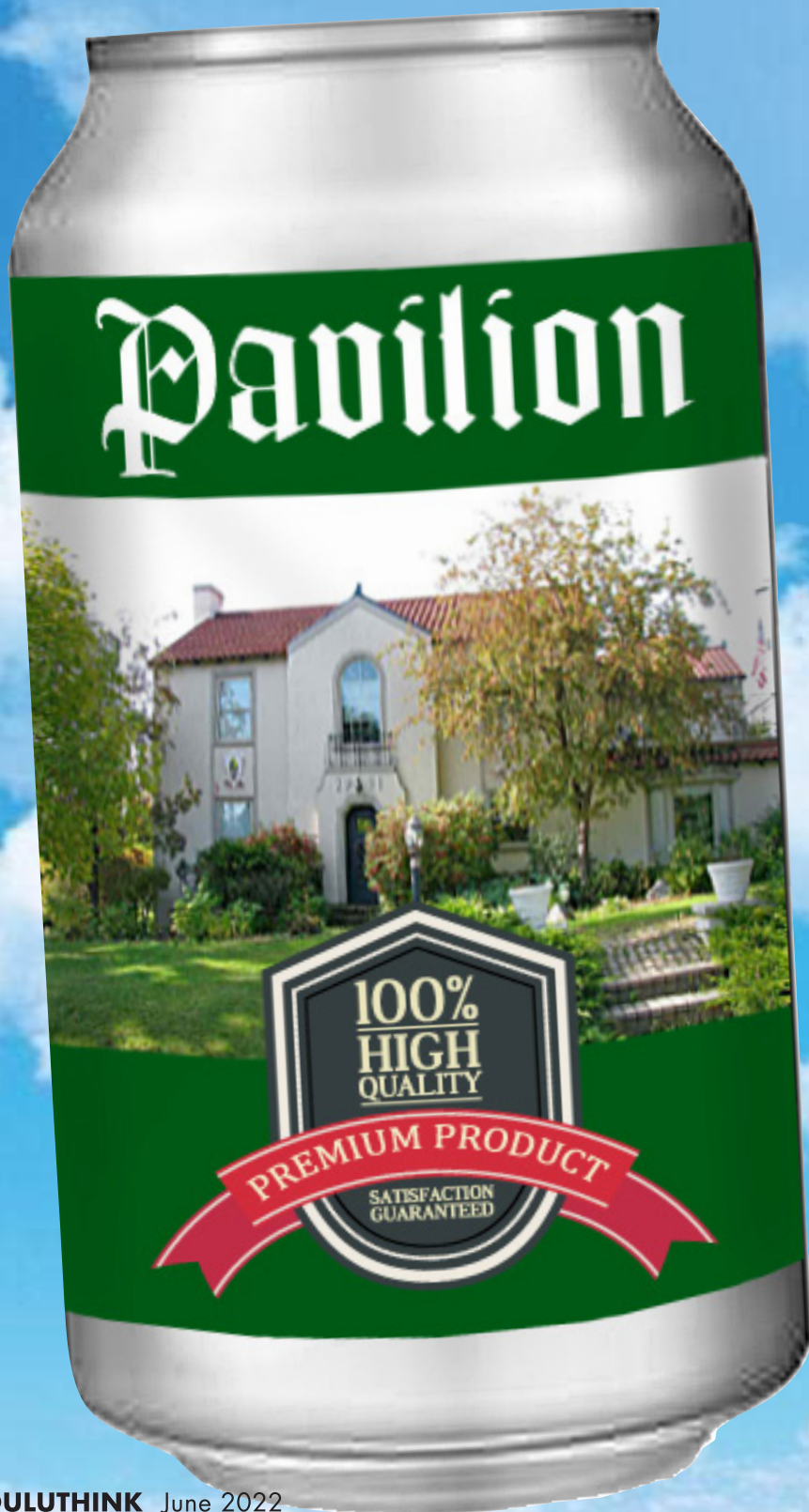

Pavilion Parties continue on the fourth Saturday of each month at the home of our “Flounder”, Bill Van Druten.

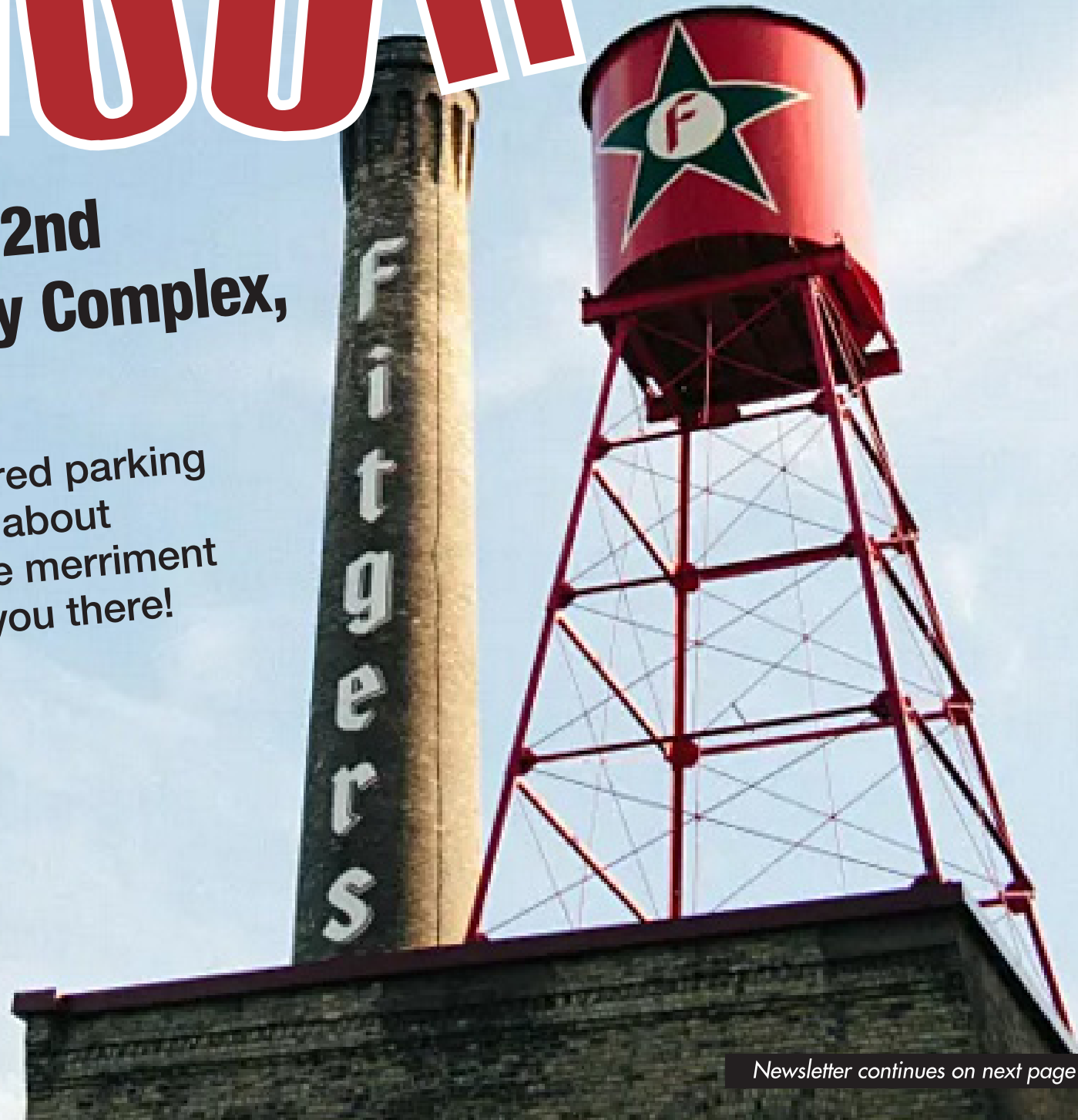
